### ALLEN TOWNSHIP COMPREHENSIVE PLAN OF 2017 PUBLIC MEETING AND PUBLIC HEARING SCHEDULE

Pursuant to the provisions of the Pennsylvania Municipalities Planning Code, public notice is hereby given that Allen Township shall hold public meetings and a hearing on May 24, 2017 to review and consider the Allen Township Comprehensive Plan of 2017, at the Allen Township Municipal Building, located at 4714 Indian Trail Road, Northampton, PA 18067. Please be advised that the following schedule shall be observed for the public meetings/public hearing scheduled for May 24, 2017:

- (1) A Public Meeting shall be held by the Allen Township Comprehensive Plan Task Force (which consists of the Allen Township Board of Supervisors and the Allen Township Planning Commission) at 6:00 pm to review and consider comments issued as part of the review of the Allen Township Comprehensive Plan.
- (2) A Public Meeting shall be held by the Allen Township Planning Commission at 7:00 pm to consider all public comments regarding the Allen Township Comprehensive Plan and to provide a recommendation to the Allen Township Board of Supervisors.
- (3) A Public Hearing shall be held by the Allen Township Board of Supervisors at 7:30 pm to consider the adoption of the Allen Township Comprehensive Plan.

A copy of the final draft of the Allen Township Comprehensive Plan of 2017 has been prepared in accordance with the provisions established by Allen Township and the Pennsylvania Municipalities Planning Code. A complete final draft is available for public review at the Allen Township

Municipal Building, located at 4714 Indian Trail Road, Northampton, PA 18067 during normal business hours and can also be viewed on the Allen Township Website ([www.allentownship.org](http://www.allentownship.org)).

Immediately following the Public Hearing, the Allen Township Board of Supervisors may consider voting on the adoption and enactment of above described Allen Township Comprehensive Plans.
